Youth Law Center’s [TAY Practice Exchange](#) is a free practice support network for civil legal advocates across California that convenes regularly to share resources, exchange technical assistance, develop referral pathways, and identify recurring issues related to the civil legal needs of transition-age young people. We provide monthly webinars, bi-monthly workshops, bi-monthly office hours, a listserv, and a dedicated [resource library](#). We've found that membership in the practice exchange is especially useful for newer attorneys or attorneys interested in learning more about the unique civil legal needs of transition-age young people.
